## What is an ESCCA Affiliated Society

Affiliated Societies of the European Society for Clinical Cell Analysis are national or regional societies that provide member benefits, which advance clinical cytometry and related disciplines in their country or region.

Affiliated Societies run activities that conform to the ESCCA mission of advancing the diagnosis, treatment and prevention of diseases in the developing and developed world. ESCCA currently counts 3 Affiliated Societies in its Community (October 2017). Please note affiliated Societies are not members of ESCCA and do not carry voting rights.

### Conditions to join as an ESCCA Affiliated Society

#### Introduction

Affiliated Societies of the European Society for Clinical Cell Analysis are national or regional societies that provide member benefits, which advance clinical cytometry and related disciplines in their country or region.

Affiliated Societies run activities that conform to the ESCCA mission of advancing the diagnosis, treatment and prevention of diseases in the developing and developed world.

Affiliated Societies are not members of ESCCA and do not carry voting rights.

#### <u>In detail</u>

Affiliated societies need to be national or regional (ie representing multiple countries within a world region) and not sub-national (ie representing only a portion of the geographical area of a country). They can however represent a subgroup within a country that is defined not by geography but by function (eg hematology, immunology etc.) Societies representing a geographical area within a country can be named and recognized by ESCCA as coming under the umbrella of the relevant ESCCA-affiliated national society, but not as individual or discrete affiliated societies of ESCCA.

Associations from the following disciplines can apply to become an ESCCA Affiliated Society

- Associations which are 100% active in clinical cytometry (multidisciplinary) or in a subspecialty of cytometry
  - Hematology
  - Immunology
  - Oncology
  - Laboratory Medicine
  - o Hematopathology
  - Clinical Research
  - Veterinary
  - Pharmacology in Human Disease

- Associations which dedicate a minimum of 30% of their overall activities to clinical cytometry in comparison to their other therapeutic area(s)
  - Transplantation
  - Infection
  - o Immunotherapy
  - o Cardiology
  - Diabetes & Nutrition
  - o Rare Disease
  - o Cancer Vaccines

# **Affiliated Societies Benefits**

ESCCA Affiliated Societies benefit from the following privileges:

- Possibility to sign up for **Collective Membership**. The members of ESCCA affiliated societies have the right to choose to pay combined membership fee for their national society and ESCCA. The regular membership fee for ESCCA is then reduced to 30€
- Priority consideration for the organization of joint events
- Priority endorsement of special courses and/or events
- Priority consideration for **ESCCA certification** examination
- Have a seat on your ESCCA Regional Board (Ambassadors)
- Announcement of courses and/or events through the ESCCA website
- Acknowledgement of the affiliated societies' role in supporting the sustainable capacity building and humanitarian mission of ESCCA in ESCCA publications and media communications

### How to become an ESCCA Affiliated Society

We ask you to submit your request to the attention of the ESCCA President, who will review the application on behalf of the Executive Committee. After a pre-approval by the Executive Committee, the ESCCA Council ratifies the status of the new Affiliated Society electronically or during their next meeting (typically held once or twice a year.

The request can be sent to XXXXXX at ESCCA headquarters (email here) and has to include:

- The filled-in application form (see end of document).
- An official letter from the Society, addressed to Pr. Katherina Psarra, ESCCA President, stating that
  - the Society wishes to become an ESCCA Affiliated Society
    - the Society adheres to internationally accepted ethical standards in clinical practice and research
- The Constitution (statutes) of the association
- The current membership list
- A short description of the society activities over the past 3 years
